

# Sweet Dreams Groom and Board Service Contract

This Agreement is entered into by and between Sweet Dreams Groom and Board and

1. I am the owner or agent of the dog named on the application form, and I am authorized to sign this release form.
- 2) I (Owner) have been provided and agree to Sweet Dreams Groom and Board's current General Policies and hold responsibility for keeping myself updated of future policy changes. General Policies are available upon request and posted on our website: [www.sweetdreamsgroomandboard.com](http://www.sweetdreamsgroomandboard.com).
- 3) I (Owner) understand and agree that my pet(s) will, at all times, while attending Sweet Dreams Groom and Board, be in good health and maintain current vaccination status. I further understand that even if my pet(s) are vaccinated, there is still a possibility of a dog contracting an upper respiratory disease or other communicable disease/parasite.
- 4) My veterinarian is \_\_\_\_\_, and I (Owner) give my vet permission to provide Sweet Dreams Groom and Board with necessary vaccination and health information pertinent to or which may be requested by Sweet Dreams employees providing care for my pet(s).
- 5) I (Owner) further understand and agree that in admitting my pet(s) to Sweet Dreams Groom and Board, Sweet Dreams has relied on my representations of my pet's health and temperament and agree to notify Sweet Dreams Groom and Board immediately of any changes in my pet's health and temperament.
- 6) I (Owner) agree to inform Sweet Dreams Groom and Board of any bite injury my pet has inflicted upon any human or animal. I (Owner) understand Sweet Dreams Groom and Board has authority to decline service to my pet in the event my pet has caused a bite to any human or animal.
- 7) I (Owner) understand and agree that all pets over six months of age attending Sweet Dreams Groom and Board group play are required to be spayed/neutered.
- 8) Sweet Dreams Groom and Board will exercise reasonable care and precautions (see General Policies) and I (Owner) understand and agree that I am responsible for any harm caused by my pet(s) to any human, other pet, or property, while my pet(s) are at Sweet Dreams and hereby assume any expense or liability for injuries my pet(s) may inflict on a human or other pet while receiving service at Sweet Dreams Groom and Board. Further, I (Owner) shall indemnify and hold harmless Sweet Dreams Groom and Board and its employees and agents from any and all claims, actions, cause of actions, lawsuits, or damages, including any claims for attorney's fees, which arise out of or are related to any action or actions of my pet(s) while my pet(s) are receiving any services at Sweet Dreams Groom -n- Board.
- 9) I (Owner) understand that dogs, when in off-leash playgroup, can accidentally injure each other. Minor cuts, scrapes, tooth punctures, and bruises are possible as a result of participation in play activities. I (Owner) also understand that pets can receive minor injuries as a result of being groomed (i.e. razor burn, minor cuts or scratches due to sudden movement). I (Owner) also understand and agree that Sweet Dreams Groom and Board, its staff, agents, and assigns shall not be liable for any injuries - or problems which may develop from any injuries - that occur while attending Sweet Dreams, provided that reasonable care, precautions, and instruction are followed (see General Policies). I (Owner) understand that I must notify Sweet Dreams Groom and Board within 24 - 48 hours of picking up my pet if my pet sustains an injury or change in health during his/her visit.
- 10) I (Owner) understand and agree that Sweet Dreams Groom and Board, its staff, agents, and assigns shall not be liable for any illness, death, and/or escape of my pet(s), provided that reasonable care, precautions, and instructions are followed (see General Policies), as a result of my pet(s) attending or participating at Sweet Dreams Groom and Board.
- 11) I (Owner) give my consent to Sweet Dreams Groom and Board to act in my behalf and in my dog's best interest by obtaining emergency veterinary care at my expense if deemed necessary. I agree to indemnify and hold Sweet Dreams Groom and Board harmless for any and all expenses relating to such emergency care.
- 12) I (Owner) agree to be financially responsible for any and all costs for continuing care of an abandoned pet(s).
- 13) I (owner) agree to pay Sweet Dreams Groom and Board's attorney and court fees in the event an action is filed against Sweet Dreams Groom and Board in relation to my pet's stay at Sweet Dreams and Sweet Dreams Groom and Board is found not liable.
- 14) I (Owner) I agree to give Sweet Dreams Groom and Board the right to use pictures of my pet(s) on Sweet Dreams Groom and Board's website, facebook page, newsletters, or any other forms of advertising. I (Owner) understand that owner will not be paid any royalty or other compensation and hereby relinquishes any and all rights for payment if a photo or video of the pet is published in any form.
- 15) All charges incurred by the Owner shall be payable upon date scheduled or at pick up of the pet.
